My Dear Friends at First Presbyterian Church of Northport,

My clergy colleagues and I often joke that we must have missed the class in seminary where they taught us how to pastor in a pandemic! Well-the truth is, of course, that there was no class in seminary about how to pastor in a pandemic. There's no manual, guideline, or roadmap to help us along the way. We just do it, trusting God to show us the way and shine light in the darkness. Thank you for your support, patience and most importantly, your prayers as we continue to emerge from the pandemic and grow into the people and the church that God would have us be. 2021 has been another year full of twists and turns that were impossible to foresee. We started this past year together worshipping remotely and doing our best to remain connected to each other during extraordinary circumstances. Our Deacons and Membership Ministries have found creative ways to reach out to church members to keep us connected while we were not worshipping together in-person. There have been numerous fire-pit get togethers, POLO outings (parents of little ones), card-writing, flower deliveries and Bible Studies. In July we returned to worshipping together in our sanctuary, albeit with reduced numbers and being fully masked. Our Sunday school and youth returned to their classes in the fall. In the season of Advent, we welcomed greater numbers of people back into the sanctuary for worship.

Just before Christmas, we had to pivot once again as our Session, Task Force and I made the difficult decision to suspend in-person worship through the remainder of the year. This time, however, we had our livestream equipment installed in the sanctuary and were able to livestream our services in real-time on Sunday mornings.

The highlight of the year for me was being installed as your Pastor on November 21. The installation service was held in the sanctuary and was a Spirit-filled celebration of God's blessings on our congregation. It was a wonderful time of celebration after having experienced such a tough year and so many losses. God is good!

I have been honored to participate in several events in our community throughout the year. On Easter Sunday, I participated in the Easter Dawn service. In September, I spoke at the "Overdose Awareness" event sponsored by the Drug and Alcohol Task Force of which I am a member. In October, I spoke at the Anti-racism rally held in Cow Harbor Park in the Village. All of these events were well-attended by the community and an important outreach for FPC.

Nothing has quite been the same this year and yet the very most important part of who we are has indeed remained the same. We are followers of Jesus Christ and together the Body of Christ. Even and especially when the path we share is unexpected and unforeseen we still travel in the same direction we have always traveled. We still walk in the direction generations of faithful Christians have trod. We follow the one who is ever leading us home to God.

I can't wait to see what God is going to do next and we reimagine who God is calling us to be in 2022 and beyond!

# Clerk's Report

**2021**. Another COVID year. Our annual congregational meeting was held in March 2021 via Zoom. Session has continued to meet on a monthly basis except for our usual break in the summer months. Our meetings open with prayer and devotions by Elders each month which this year included readings from a writing by Shelly Cunningham (Lutheran Pastor from Minnesota) about the need for people of faith; "Walking with God" by David Jeremiah; "Valley of Vision" from Collection of Puritan Prayers; devotion from the Pentecost Service at Fifth Avenue Presbyterian Church in NYC; devotion by Lutheran Pastor Annabelle Markey based on Mark 9 v. 38-50; reading of 1st Peter 5; devotion on gratitude from the Reverend Marcus James. Additionally, Session members read and discussed The Post-Quarantine Church by Thom S. Rainer.

On January 24, 2021 the following Elders were ordained and/or installed for three year terms: Pat Bell, Cathy Coleman and David Ofsharick; Anita Stambouly and Cindy Mies for a second 3 year term; Julia Graziano (Youth Elder) for a 1 year term and Carole Gandy for an unexpired 1 year term in class of 2021.

Our corporate officers remained as Marcia Mercer, President; Carole Gandy, Secretary; Bob Spiller, Treasurer; and Marcia as Clerk for an additional one year term. Sadly we lost Carole this past year and Dennis Crowley was elected by Session to serve as Secretary in January of 2022.

We were deeply saddened to lose several dear and faithful members of our church family this past year: Robert Shevlin, Robert White, Jessie Clark Shaw, Charlene Cosman, Barbara Sanderson and Carole Gandy.

We thank outgoing Elders: Joan Armet, Dennis Hartin, and Christine Spiller.

Our Church reopened in July of 2021 and in-person worship services and other activities were back in the swing with livestreaming available for those unable to attend. Unfortunately, though, due to a new COVID variant we once again closed our doors starting with Christmas for several weeks for safety precautions. But thanks to diligent work by our Reopening Task Force and others we are once again back in our beloved sanctuary.

And last but not least, and at long last, Pastor Rachel officially become our "Installed" Pastor effective November 8<sup>th</sup> with her installation service being held on November 21<sup>st</sup>! Hallelujah!

I pray you all remain safe and healthy and hope that we can continue to worship and sing and pray together in our beautiful sanctuary.

# **Finance Ministry**

The highlight of the year was the creation of our Endowment Fund with the Presbyterian Foundation in the Spring of 2021 with an initial deposit of 200,000. An additional 400,000 from the bequest of Charlene Cosman was added to the Fund in September, 2021. All of this was preceded by months of review and analysis by the Finance Ministry as to how to make the best use of our liquid assets. An additional 50,000 was added to the Fund by Finance in January, 2022.

There has been deep concern about the decline in both the number of pledges in the past two years as well as the amount pledged. We are, with some reluctance, presenting a budget for approval that is approximately 68,000 short of the Church's income, both in pledges and in other categories. We do this after a careful review of the upcoming expenditures for 2022, which we feel are both realistic and necessary for First Presbyterian to grow and meet the needs of all areas of the Church, including Sunday School and Mission activity. We are fully cognizant that it would be both irresponsible and poor stewardship to present a deficit budget several years in a row, and we aim to spend wisely and in line with current giving, and not relying on investment earnings to balance the budget.

Besides the hoped-for ending of the pandemic, we face the issues of inflation and the expected increased needs of the community. In the coming months, we, along with the Session and other committees, hope to reach out to our congregation to greater clarify our financial needs.

Our longtime chair, Peggy Denniston, retired from her position on December 17, 2021 and Finance member Dennis Crowley was elected chair. Our thanks to Peggy for her tireless work on setting up the endowment fund.

- ~During the summer months, the Deacons hosted Coffee Hour each week. Small waters and packaged treats were served.
- ~On September 26<sup>th</sup>, Jesse Shaw's ashes were committed to the Memorial Garden and the Deacons served refreshments.
- ~On October 3<sup>rd</sup>, Steve Siegmann's ashes were committed to the Memorial Garden and the Deacons organized and served refreshments.
- ~On October 9<sup>th</sup>, Barbara Sanderson's Memorial Service was held and Deacons were called upon to serve.
- ~As of October, the loose plate offering will go to Mission.
- ~Coffee Hours going further will be hosted on a rotating basis between Deacons, Session, and Membership.
- ~A donation of \$1,000 was made to PDA for the Afghan refugees and for Hurricane IDA relief.
- ~In November, the Deacons hosted a farewell coffee hour in honor of Faye Michels, who moved upstate.
- ~In November, a Memorial Service was held in honor of Carol Gandy and the Deacons were called upon to serve.
- ~On November 21<sup>st</sup>, the Deacons hosted a reception in honor of Pastor Rachel's Installation.
- ~In December, poinsettia plants were delivered to the Pioneers and senior members of the

# **Membership Ministry**

The Membership Ministry has continued to minister to our congregation throughout this second year of the pandemic with many of the same projects as last year. Designed to reach members of our church community safely and compassionately, we have tried make everyone feel connected to the church, remembered and valued.

Virtual and in-person activities have included weekly prayer meetings over Zoom each Wednesday, Saturday morning hikes at Sunken Meadow State Park, Firepit Fellowship gatherings and occasional POLO in the Park playdates for "Parents of Little Ones." We are also supporting Deacons and Session with hosting coffee hours every third week (when it's safe to gather indoors, that is). Membership sent Christmas cards to all church households in December and wrote personal cards of encouragement to all church members early in 2021 and again this past fall/winter. In late 2021, we began sending birthday cards to children of the church, and in February 2022 we began listing monthly birthdays of all members in the weekly email. The latest project we are sponsoring is a church-wide art project in which all church members are encouraged to help fold 1,000 Origami Cranes, writing prayers of hope and gratitude on each one. Membership will assemble the cranes into a piece of hanging "prayer art" to be displayed in the Hartt Room in the spring.

A new member class is being held in early March, 2022, and we anticipate, with great joy, the addition of some new members to our congregation. Despite the challenges of our world in 2021, people are finding our church which is certainly something to celebrate! Libby Yoskowitz, Chair



#### **Local/Global Mission Ministries**

The 2021 discretionary funds received by Local/Global Mission Ministries were disbursed as follows: Donations were made to Presbyterian Disaster Assistance (PDA) to aid victims of Hurricane Ida in Louisiana, to provide help to residents in Haiti following an earthquake there, and to provide aid to people living in Texas and the South West in the aftermath of severe winter storms and freezing temperatures that seriously damaged many of their homes and businesses. The Presbyterian Agency Living Waters for the World was the recipient of Mission funds as well.

Thinking locally, providing food for hungry people was once again a mission priority in 2021. Donations were made to assist the Helping Hand Rescue Mission in Huntington Station, the Deacons' "Love Offering" of Iglesia Evangélica Presbiteriana Nueva Vida, and Long Island Cares. Mission Ministries sponsored four HIHI dinners for homeless residents spending the night at Gloria Dei Lutheran Church in South Huntington. Members of our congregation graciously

offered to help prepare meals for them. A donation was given to the YDA to assist this Youth Development Agency's general budget. The Presbytery of Long Island also received a donation in support of New Church Development ministries.

Money was donated to Doctors Without Borders to assist in their extensive Covid relief efforts in South India. In addition, we asked members and friends of FPCN to donate clean, empty pill containers to be mailed to Matthew 25 ministries in Ohio. This organization works closely with Doctors Without Borders. The pill containers will be included in bulk shipments of medicines that are sent to volunteer medical personnel serving in communities around the world. Doctors will use them to dispense medicines to patients in a sanitary, sensible way. Slightly over 100 containers were received from members of FPCN and mailed out. It is gratifying to note that those plastic containers did not end up in local landfills but, instead, were used to help bring healing to the sick.

In response to mission listings in the Presbyterian World Mission Giving Catalog, donations were made in support of the following programs: refugee families were provided with emergency life packs, and generous food baskets. Farmers were given "family nutrition starter packs" which contained seeds for kale, tomatoes, onions, cabbage, and okra. And rural families received the gift of chickens.

As in the past, Mission Ministries invited the congregation to donate to the three PCUSA special offerings. Here is the total amount of money received in 2021: One Great Hour of Sharing, \$2,085.00; Pentecost Offering, \$1,561.00; and the Christmas Joy Offering, \$2,017.00 -- gifts totaling \$5663.00.


We thank you all for your generous donations to these three special offerings.

#### **Stewardship Ministry**

And your ancient ruins shall be rebuilt; you shall raise up the foundations of many generations; you shall be called the repairer of the breach, the restorer of streets to dwell in. Isaiah 58:12 We have moved into the 2022 church year facing our normal operating costs even though we are in a pandemic. Current pledge information shows that we have received pledges for \$326,072 for 2022. This compares to \$364,758 pledged by this time last year. Our goal is to reach \$400,000 in pledges to plan for 2022. We are 82% of the way to our goal. You can still make your pledge. The Finance Ministry faces great difficulty in preparing an annual budget when adequate pledges are not made and they have to deal with estimated income sources.

The per capita assessment this year is \$38.08 per member. We encourage everyone to add these expenses to their pledge giving to help defray the costs.

The Stewardship Ministry has been working by Zoom and email to develop the pledge campaign and encourage Stewardship in the church. We recognize that continuing information regarding how the church is both receiving its revenues and how it is spending its money is not only meaningful but necessary.

Even though at times, the church has been closed to worship during the pandemic, we hope to remain open going forward. We still need funds to keep the church building functional, and to pay salaries. In addition, the missions of our congregation have continued, such as keeping the food pantry open and contributing towards disaster assistance. We urge each member of the congregation to accept his or her personal responsibility in providing the income necessary to permit our church to continue its work in our community as well as the world. Our ministry and mission calls for us to do this both joyfully and spiritually. We must all accept this responsibility seriously. All that we have is from God. This is a way for us to say "Thank You". We need to commit to the fact that giving to our church must be a part of our spiritual growth in response to

the gift of Grace we receive from our God. Giving of our time, talent, gifts and service is a way to serve our Lord.

We also were able to hold our summer camp for 6 weeks during the summer of 2021. The teachers did a wonderful job of planning the weekly themes and making every day special for our campers.

We began our 2021/2022 school year with a full school! We felt so fortunate to have every class at capacity. We were able to hold our annual Back to School Fair and Halloween Parade and show for our families. All of our specials classes are in person and the students are thrilled to participate in every one. As this school year has unfolded, we have been able to relax certain COVID restrictions. At this point, masks are optional for all of our students and staff. We are hopeful that this is the start of a return to normalcy!
