Trinity recently implemented an option for individuals to give money to Trinity through our new On-Line Giving process. You can find this option on our website at **trinitypresbyterian.net.** Select the "Give" tab in the upper right portion of the screen and follow the instructions. #### On-line Giving FAQs Trinity Presbyterian Church, Topeka, KS

1. How does one give online?

Select the "Give" button on Trinity's website and you will be prompted for the needed information.

- Do I have to set up an account to give online?
  No. However, creating an account would allow you to set up recurring payments and to review your payment history.
- 3. Are there processing fees associated with giving online? Yes. For each donation, the fee is 2% of the total donation.
- 4. Who pays the processing fees associated with giving online? The donor is given an option to add an extra amount to help offset the 2% fee. Otherwise, Trinity incurs those fees.
- 5. Will online donations appear on Trinity's tax statements? Yes. The donor is given credit for the total donation, including any offset amount. So, if the donor includes the \$2 processing fee for a \$100 donation, the donor gets credit on their statement for \$102. The donor will also receive a year-end tax statement from the Presbyterian Foundation reporting the donor's total donations for the year.
- 6. How does the donor specify the purpose of their donation? There is a note section in which the donor is encouraged to indicate the specific purpose of their donation. This would be similar to using the memo line on a check and is necessary to insure the donation is used for the purpose intended.

## FROM THE TRINITY FINANCE COMMITTEE

If you are 70 1/2, you may gain a significant income tax advantage by directing your individual retirement annuity (IRA) distribution to Trinity as a qualified charitable donation. Your distribution would be tax free and, of course, would have no tax implications for Trinity. This provision in the tax law would also apply to required minimum distributions from IRAs when you

turn 72. This provision may be particularly beneficial because with the increase in the federal standard deduction, many people no longer realize a tax benefit from deducting charitable contributions as itemized deductions. By making the annuity distribution a direct gift to Trinity, your reportable income is reduced, resulting in a tax savings. You should consult your tax professional if you are interested in accessing this benefit to both you and Trinity.

# As you prepare for the busy holiday season, please keep in mind the following dates:

#### Friday, November 29, 2020 Stock Transfers

If you are considering a gift of mutual funds or appreciated securities, Trinity suggests you begin to initiate your transfers by November 27 to allow sufficient time to process your gift. Please contact Carol Shannahan, before you make the transaction. Our broker will notify me of the amount of the sale, and the name of the stock; but, I have no way of knowing the owner or purpose of the fund or stock gift if you do not speak with me ahead of time. This advance knowledge will of your gift will help me to track the transaction easier.

#### December 2020 2021 Weekly Pledge Envelopes

Boxed sets of 2021 pledge envelopes are available, please call the church office or Carol Shannahan (559-8551), to arrange a time to pick them up, if you would like to have them. You do not have to use these envelopes; you may use any other envelope you choose. The important thing is to write "Pledge", or appropriate account, on the memo line of the check.

# UPDATE FROM FROM THE PARISH NURSE

The updated graph on the next page is more comprehensive than that which was previously included in a past Talking Trinity newsletter. *Increased knowledge of the disease and evidence based practices have changed* treatments and guidelines over the last several months. Several other key take-away points from a recent symposium on COVID-19 and Pediatrics by a KU Med. Center physician and associate professor are:

- ✤ COVID in children— see the chart for age related symptoms.
- Ibuprofen and Acetaminophen (Tylenol) now approved for use.
- Hydrate! Hydrate! Hydrate!
- Importance of actually being seen by a doctor (not just Telehealth) if symptoms persist or increase in intensity to obtain a correct diagnosis... lots of other illnesses can cause same or similar symptoms.
- If exposed to a known case, test a minimum of <u>5-7 days after exposure</u> (unless symptomatic); otherwise test is likely to come back negative since they may not have enough virus in their system to test positive. Many people are being tested too early to know if they have COVID, and then they are spreading it! Importance of quarantine if known exposure.
- Even those with asthma should wear masks... there are only rare exceptions.
- Masks, socially distancing and good, frequent hand washing are all important factors in reducing transmission to others, especially in the older adult population which is most at risk for serious illness, long-term health complications, and even death.

Ages 10-18 - Most common symptoms: Headache, cough, sore throat, fever, muscle aches, shortness of breath, diarrhea, nausea and vomiting and loss of taste/smell.

"Be Thou My Vision." I think it is very timely for today... a hymn that truly transcends time!

Be thou my vision, O Lord of my heart; naught be all else to me, save that thou art thou my best thought, by day or by night; waking or sleeping, thy presence my light.

Be thou my wisdom, and thou my true word; I ever with thee and thou with me, Lord. Thou my great Father; thine own may I be, thou in me dwelling and I one with thee.

Riches I heed not, nor vain, empty praise; thou mine inheritance, now and always; thou and thou only first in my heart, high King of heaven, my treasure thou art.

High King of heaven, my victory won, may I reach heaven's joys, O bright heaven's sun! Heart of my own heart, whatever befall, still be my vision, O Ruler of all.



These words are attributed to a 6th century poet, St. Dalian Forgaill, in his poem, "*Rop tú mo baile or Rob tú mo bhoile*" in the "Old Irish" language. This prayer poem was passed down through the centuries, and was translated to English in 1905 by Mary Byrne. The best-known English version was translated by Eleanor Hull and published in 1912. It is one of the most sung hymns in the United Kingdom.



As we end this year and venture into the New Year, no matter the storms in one's life, keep your sight and focus on Jesus and "BE NOT AFRAID!"... another beautiful song by Bob Dufford, SJ. https://www.youtube.com/watch? v=snmwD6d9Xo4 Truly these are God's words to take to heart to give you comfort and strength! The 3 "R"s include -- Reduce, Reuse and Recycle

If we can reuse items then we can reduce the amount of packaging as well. Not having items delivered in plastic packaging but in cardboard boxes which can be recycled is helpful. Try to choose items which do not have a lot of plastic packaging in the store or when ordering online.

Formaticum.com - has new reusable plastic bags for any foods on their website. "All foods deserve to be kept fresher longer.' These bags are made of a "unique material that preserves freshness and postpones food spoilage, helping it last twice as long as other storage alternatives." These bags are



reusable -- just wash in warm soapy water and air dry between uses. When done, they are 100% recyclable. A package of 10 costs \$8.

Remember that "living cheese is a... balance of aroma, taste, texture and appearance" Using the cheese storage products keeps cheese fresher much longer, keeps it from turning moldy and having to be thrown out or cut off of a block of cheese. Biodegradable cheese sheets or cheese storage bags or cheese storage paper all offer easy ways to protect the special freshness of cheeses instead of plastic packaging or once it's opened. Makes great gift ideas to help others be more environmentally conscious, too!

### Finding Joy in 2020

There are lots of ways to say it – but working together really does make bigger and better things possible. And, lots of times, working together makes it more fun, too. In fact, there are times made better just by our ability to be together, to be with one another.


