

# **Continuing Health Guidelines**

As I write this, many of us will have had our first or second vaccine. And there is great eagerness to get back to "normal" in our lives, and in our worship. The CDC has issued guidelines about what life will be like "after vaccinations."

### From the CDC:

- People are considered fully vaccinated:
  - ◆ 2 weeks after their second dose in a 2-dose series, like the Pfizer or Moderna vaccines, or
  - ◆ 2 weeks after a single-dose vaccine, like Johnson & Johnson's Janssen vaccine

◊ If it has been less than 2 weeks since your shot, or if you still need to get your second dose, you are NOT fully protected.

Keep taking all prevention steps until you are fully vaccinated.

Churches should follow state and local guidelines, and be up to date on local conditions.

- ◊ Going forward, we will continue to:
- $\diamond$  Wear masks in worship.
- Social Distance in worship- this will limit the number of people who may worship together. A second space for overflow, with video, or a second service, may be indicated. (note: guidance from the CDC about school children sitting 3' apart in classroom settings does NOT apply to adults in worship)
- ◊ Continue with on-line worship, as well as in-person, to limit the number and protect congregation members.
- Olean and disinfect between church services.
- Ave increased ventilation of fresh air (not heater or ac- those should bring the worship space up to temperature, and then be shut off prior to people coming in, since re-circulated air, even with filters, can spread the virus.) Windows and doors should be opened to let fresh air circulate.
- Sessions and their pastors should set benchmarks based on local numbers of infections to determine at what point inperson should be suspended.

The church is not "closed." The church has not been closed, this past year. What we have done is find new ways to worship, ways that allow us to care for one another, and others in the community, by taking precautions regarding health and safety.

# **Report on iCARE & Ethiopia**

March 21, 2021

One of Presbytery's missions is the iCARE Committee which was formed in 1999. The name is an acronym meaning Illubabor Children's Agape Response. Through this committee, individuals and churches currently support 53 children at the Gore Home for Children in Gore, Ethiopia. The Home is an orphanage managed by the churches in the surrounding area. The Home is run by Kes Ayana Hedu, a pastor whose job this is.

Gore is a small town in the Western part of Ethiopia. Ethiopia has been having civil unrest, but that has been in the Tigray region to the North in the country. Also an issue has been the unrest in South Sudan that is not so far away to the NW of Gore. The unrest in South Sudan has pushed nearly 500,000 refugees into Ethiopia, thereby pushing prices for food up. With the crisis economy created by both these conflicts, inflation in 2019 was 15.8% over the previous year, inflation in 2020 was 20.16% over 2019. Kes Ayana tells me that food now costs more than twice what it did before.

Covid-19 is also hitting Ethiopia. However, here the physical isolation is helping. In Gore and Mettu (a larger nearby town) 90 folks were found positive, but no deaths yet.

Students at the Gore Home get meals and clothes. They are close enough to walk to the town school. They get tutoring help if they need it and a spiritual upbringing. There's supervision and a dorm mother. Someone cares about them. In  $10^{th}$  grade, students take a national exam (in English), and if they score high enough (top 5%) the National

Government will pay their University fees. An amazing number of Gore graduates have been able to make use of this program. One can literally come to the Gore Home after living on the streets, apply yourself for a number of years and come out with a college degree (which effectively guarantees you a job). That's an amazing success!!

If you would like to help with this mission, please contact one of the names below. It would make <u>such a big</u> <u>difference</u> in the lives of these children.

# A One Great Hour of Sharing Needs Your Help

As active members of the Shenandoah Presbytery Disaster Preparedness and Response Team, and members of the Presbyterian Disaster Assistance National Response Team, we would like to take a moment to speak on behalf of the One Great Hour of Sharing Offering (OGHS). The One Great Hour of Sharing Offering is one of the four church-wide offerings of the Presbyterian Church (USA). It is most commonly received during the weeks leading up to Easter. The Offering provides support for Presbyterian Disaster Assistance (PDA), the Presbyterian Hunger Program (PHP), and the Self-Development of People Program (SDOP).



It is likely no surprise to anyone that the OGHS Offering was down by 50% in 2020. What

that means is that these three programs – PDA, PHP and SDOP – had their budgets cut by 50%. In a time of great need for our neighbors, these programs had seriously diminished resources to provide assistance. PDA was in a slightly better position than PHP and SDOP because PDA's ministry is more visible. We see the need for disaster response on our TV's regularly with news reports of storms, fires, and flooding. So, PDA's voluntary designated donations continued. PDA also used \$3.5M from reserve funds to provide COVID grants to churches serving marginalized communities.

All three of these programs work regularly to meet the goals of being a Matthew 25 denomination. One Great Hour of Sharing is the largest way that Presbyterians come together in mission and ministry to be "repairers of the breach" (Isaiah 58). The work focuses on material need and their root causes — from direct famine and disaster relief to the implications of systemic racism and poverty. As you prayerfully discern your participation in the One Great Hour of Sharing Offering, please consider that we are called to be repairers of the breach and to serve as Jesus said – the least of these our brothers and sisters. And to that discernment we leave you with this prayer:

Savior, do not meet us where we are, but find us where you are instead: with those experiencing injustice, hunger, thirst and great need. Amen.

# **One Great Hour of Sharing**

The PCUSA tells us that One Great Hour of Sharing is the largest way for Presbyterians to come together in mission. One Great Hour of Sharing is one of four Special Offerings connected to a season of the church year and mandated by the General Assembly to help the whole Church join together in response to God's grace. Resources are available for this Special Offering starting in January and are available by going to presbyterianmission.org/oghs

Congregations collect contributions for this Special Offering during the Lenten season.

Congregations then send these funds to the presbytery and in turn 100% of the One Great Hour of Sharing contributions from all the Shenandoah Presbytery churches is sent to the denomination.

The PCUSA uses your generous offering to support the Presbyterian Hunger Program, Presbyterian Disaster Assistance and Self- Development of People.

- PRESBYTERIAN DISASTER ASSISTANCE (PDA) : Works alongside communities as they recover and find hope after the devastation of natural or human-caused disasters, and support for refugees : Receives 32% of funds raised
- PRESBYTERIAN HUNGER PROGRAM (PHP) : Takes action to alleviate hunger, care for creation, and the systemic causes of poverty so all may be fed : Receives 36% of funds raised
- SELF-DEVELOPMENT OF PEOPLE (SDOP) : Invests in communities responding to their experiences of oppression, poverty and injustice and educates Presbyterians about the impact of these issues : Receives 32% of funds raised

Thank You to everyone who contributed to the February Presbytery meeting offering! This collection is going to support the 4 cents a meal program.

When churches and individuals contribute to the 4 cents a meal program you are directly helping to stop hunger. You are not just supplying food but helping to support programs that have goals to tackle issues before people need to go to the food pantries.

When individuals give funds to their churches, the helping starts immediately because churches keep 25% of the collection for immediate local use. The remaining 75% is sent to the presbytery and our Committee on Mission and Outreach prayerfully divides the funds to international, national, and local programs. # Vandalism & Mail Stolen from Church Mailboxes

An article entitled "The Growing Problem of Mail Theft at Churches" was in a recent issue of Church Law and Tax Report.

After reading this article, I realized this is a concern for many churches, not just our church. I would like to share with you our church's recent experiences with stolen checks payable to the church.

To our knowledge, mail was stolen from our mailbox twice between August 1, 2020 and December 31, 2020. We are not aware of other dates this may have occurred prior to August 1.

August 2020 - The first instance involved two checks payable to the church, endorsed by individuals and deposited through an ATM machine at a local credit union. Since the checks were payable to the church, they were flagged by the Fraud Department of the credit union. This department contacted our church to verify we had not received the checks and given them to an individual. One of the checks was typed, the other hand-written, neither was from a church member.

The amount on the hand-written check had been altered for a much larger amount than originally written. Our church immediately contacted those who wrote these checks, our church members, the local police department and the post office. We also secured on our mailbox post a locking security mailbox.

December 2020 - The morning of December 29, 2020 one of our members noticed the security mailbox had been removed from the post sometime between the afternoon (after our secretary left for the day) of December 28 and the morning of December 29. The local police department was contacted and upon searching the area surrounding the church, found the mailbox behind some shrubbery. Our member shook the mailbox to see if any mail would fall out, it did not. Our church secretary unlocked the mailbox, and it was empty. The assumption was that no mail was in the box when it was removed from the post. The church rented a P. O. Box and did not secure the mailbox back on the post. A few days later the member who secured the mailbox to the post in August, turned the mailbox in different positions, He discovered when

> the mailbox was not secured to a post or building, it could be turned in a certain position allowing the mail to drop into area where it could be removed while the box was still locked. A few weeks after this, we were contact by a lady (non-member) who discovered a check she wrote and mailed to the church as a memorial gift, cleared her bank account for a much larger amount than written. She contacted her bank and the church. Her check had been "washed". Everything she had written on the check, including her signature, had been removed and new information written on the check. This check was endorsed by the

"new" payee and another individual and processed through an ATM machine at the same credit union as the first stolen checks. Since the church's name had been removed from the check, there is no proof the check was payable to the church and stolen from our mailbox, we cannot pursue filing changes against the individuals. We are currently working with the lady whose check was stolen, her bank, the credit union, and the local police department to resolve this issue. In our case a locking, security mailbox did not prevent someone from

### Here are suggestions from the article of ways to protect your mail & contributions from your members (donors):

- Invest in security cameras
- Re-locate mailbox (if permissible by the local Post Office)
- Rent a P. O. Box
- Encourage members (donors) to review their bank statements upon receipt
- Send periodic statements to your members (donors) for their review and reconciliation of checks payable to the church.
- Encourage members (donors) to review their statements from the church upon receipt to ensure the church did receive their gift. Although, the check may have cleared their bank account, this does not guarantee the church received and deposited the check.
- If the church office is not open daily, arrange for someone to check the mail daily after the normal delivery time.
- Have a secured area in which the person picking up the daily church mail can leave mail for authorized individuals.
- Have a plan for delivery of packages not delivered by the Post Office.
- Have your member (donor) contact their bank immediately upon discovering a possible fraudulent check on their bank statement
- Have coverage for stolen checks, monies included on your church insurance policy.
- If possible, encourage online giving.
