# INFORMATION PERTAINING TO MEETINGS OF PRESBYTERY Per Presbytery Manual Chapter V

<u>Number of Meetings</u> – Our Book of Order (G-3.0304) requires presbytery to hold stated meetings at least twice each year. At this time, there will be four <u>STATED</u> meetings for 2021: February 27, May 25, August 28, and November 16.

<u>Kind of Meetings</u> – Besides stated meetings there are adjourned meetings and special meetings.

<u>Adjourned Meetings</u> – Held to conclude unfinished business of preceding stated meeting. New Business may be placed on docket.

<u>Special Meetings</u> – The moderator shall call a special meeting at the request of, or with the concurrence of, two ministers and two elders being of different churches. Should the moderator be unable to act, the stated clerk shall, under the same conditions, issue the call. If both moderator and stated clerk are unable to act, any three ministers and three elders, the elders being of different churches, may call a special meeting. The Synod may direct the Presbytery to convene a special meeting for the transaction of designated business. Notice of a special meeting shall be sent not less than ten (10) days in advance to each minister and to the session of every church. The notice shall set out the purpose of the meeting and no other business than that listed in the notice shall be transacted.

<u>Who Determines Type of Meetings?</u> – The presbytery itself. If the business at a stated meeting is not completed in the time allowed on the docket, then the presbytery votes to extend the time on that day or votes to schedule an <u>adjourned</u> meeting later. <u>Special</u> meetings may be called in conformity with presbytery's policy, expressed in its manual.

<u>Docket Preparation</u> – The Presbytery Meeting Planning Committee composes the docket. Time periods for committee reports are arranged in consultation with chairs and others responsible for reports.

<u>Docket Problems</u> – The times listed for the presentation of reports are only general orders, and not orders of the day, unless specifically noted (see Procedural Rule A). Frequently, debate bogs down over procedural matters, and controversial issues create considerable discussion. Presbytery can always limit debate. Candidates and transferring ministers of necessity may require special considerations for their examinations because of such things as travel schedules and seminary schedules. The docket may be amended at any time during the meeting. Commissioners should be aware of possible extension of time needed for such amendments and the possible delay in adjournment.

#### PROCEDURAL RULES

#### 5.5. OPERATING PROCEDURES

- 5.5.1. The Presbytery shall in its proceedings abide by the requirements of the Constitution of the Presbyterian Church (U.S.A.), its Standing Rules or Manual of Operations, and Robert's Rules of Order (newly revised) in this order. A list of procedural rules adopted by Presbytery shall be printed on the inside cover of each handbook.
- 5.5.2. A report of any agency of Presbytery requiring more than 10 minutes of Presbytery time may be made an Order of the Day.
- 5.5.3. Reports having been mailed out in advance, the committee chairperson shall not read the report except to make reference to a few highlights of the report and to recommendations by numbers, moving their adoption.
  - A. Any reports not included in the Handbook shall be submitted as part of a Supplemental Report available either electronically or on paper distributed prior to the beginning of the Presbytery meeting at which the report is presented.
  - B. Any report not so circulated shall not be received by the Presbytery except by approval of the governing body by a two-thirds vote of those present and voting. If a group wishes to submit such a report, a person shall summarize its content and purpose before the vote is taken.
- 5.5.4. On matters where there may be deep concern, possible controversy or lack of information, the committee making the report shall provide critical background information, so that the governing body may expeditiously make wise and considered decisions.
- 5.5.5. Debate shall be free and open, with equal time being given to proponents and opponents insofar as possible.
- 5.5.6. Any member of the governing body desiring to speak must stand, identify themselves by name and congregation, be recognized by the Moderator, and go to a microphone if available.
- 5.5.7. A member of the presbytery may speak twice on any particular motion, and not for more than a total of five minutes, but the second time may only be granted after all who have not yet spoken have had an opportunity to do so. The maker of the motion is entitled to speak first, if desired.
- 5.5.8. Lengthy motions must be written out and presented to the Stated Clerk.
- 5.5.9. References to the following procedures from Robert's Rules of Order may prove useful:
  - A. A committee recommendation does not require a second to be on the floor.
  - B. Other motions require a second prior to discussion or action.
  - C. When there is no apparent disagreement or objection to a motion, the Moderator may declare it is adopted by common or general consent.
- 5.5.10. No flash photography will be allowed during the worship service at meetings of Presbytery.
- 5.5.11. When Presbytery meets in a location where seating is limited, priority shall be given to voting members for seating within the meeting area. If it is necessary to use other rooms for overflow seating, visitors and other non-voting members shall use these areas.

#### 5.5.12. **QUORUM**:

A quorum of the Presbytery shall be any ten teaching elders and ten ruling elders from at least ten different congregations. (G-3.0304).

## CAITILIN R. HOY BIOGRAPHICAL SKETCH

I was born and raised in Michigan where God first brought me to faith. Looking back over my life, I can see how God was always gradually drawing me to my spiritual home, the church, reconciling me through Christ. Specifically, God brought my family and I home to a place of healing and transformation for us: First Presbyterian Church of Elk Rapids, MI. My son, Nicholas, and I were baptized there together by the Rev. Dr. Daniel Herlein in 1999. It was in this church's loving fellowship that God brought me to faith in Christ as my Lord and Savior and I committed my life to following Jesus. I confessed and repented of my sins, becoming transformed in Christ as a new creation. I immersed myself in reading the Holy Scriptures, and raised my son in the body of Christ, the church.

In the following years I became very involved in the life and ministry of the church, growing in my faith, learning and thriving in worship and in small groups, serving in the Stephen Ministry, and becoming the Director of our after-school children's outreach program, "Lighthouse Kids." I discerned God's calling in my life to be a Presbyterian Minister and specifically at the time, to be a health care services Chaplain. I completed my BA in Family Life Education through Spring Arbor University and in the summer of 2004 my son and I moved to Richmond, VA where I attended Union Presbyterian Seminary. I graduated from UPS with my MDiv in May 2007. I graduated from the Clinical Pastoral Education residency program of VCU in August 2008 with my MS in Patient Counseling having completed four units of CPE total. I was ordained by the Presbytery of the Mackinac in October 2009. I served in Richmond, VA as Chaplain in area hospitals and at Westminster Canterbury of Richmond, a continuous care retirement community. I began to consider joining the Navy Chaplaincy due to several connections with military members that I had met in seminary and as a hospital chaplain.

To fulfill the 2-year parish ministry requirement of chaplains going into the service, I served as a supply pastor for Rivermont Presbyterian Church in Enon, VA. My time with Rivermont Church evolved and we spiritually formed together into a very meaningful ministry. It was in my service to the folks of Rivermont church that I realized that I truly enjoyed, thrived in, and could make a positive impact as a Pastor in a small church. As I look back now, I can see that God was showing me how well suited I am to be a Pastor. I joined the United States Navy in August 2011 and attended military basic training -Officer's Development School- in Newport, RI. I completed the course and went on to the Naval Chaplaincy School and Center in Fort Jackson, SC. Due to urgent family needs which caused me to realize that this was not God's calling for me in my life, I made the difficult decision not to continue as a Navy Chaplain. I continued working in the Navy until I received an honorable discharge and returned to work in the healthcare chaplaincy at Westminster Canterbury of Lynchburg. After more earnest experiences in the healthcare chaplaincy, most notably and recently, at Williamsburg Landing, God has brought me back into parish ministry, to serve the good people of Waynesboro Second Presbyterian Church with so much joy and gladness.

I deeply admire and have an even greater respect for all military members and veterans as a result of my time in the Unites States Navy. Likewise, I am thankful for all the people I cared for in the healthcare chaplaincy. I am thankful for all my vocational experiences as they have deepened and broadened my faith, helping me to learn and grow in my pastoral identity, to become more spiritually mature, and refined for me that at this time in my life, I am well suited for and prepared to be a pastor in the local church setting.

The overarching call to ministry for me has always been to share the message of God's love, justice and mercy. I am a messenger of God's hope. I believe that God loves all of God's people unconditionally. It was through my awakening to Christ in my life and subsequent calling to ministry that I realized what I had been created for- to serve God by sharing God's love with others; I seek my "chief end ... to glorify God and to enjoy him forever" (Westminster Confession Shorter Catechism). Through

my prior experiences God has been preparing and forming me for what I am uniquely designed by God to be with joy and gladness- a Pastor. God is calling me to return to the church that I was spiritually formed in so that with the benefit of my experiences, insights and spiritual maturity, I can love, nurture, teach, shepherd, challenge, renew, and grow the people of Waynesboro Second Church. I will be honored and thankful to serve God as a Pastor here in the Shenandoah Presbytery. I consider it a blessing and joy to stand with you all in ministry. With all our experiences and hearts pooled together, we are a compassionate compelling force empowered by the Holy Spirit to spread God's message of love, justice and mercy in Virginia and to the world.

### CAITILIN R. HOY STATEMENT OF FAITH

God is the one, true, living, and holy God who creates, redeems, and sustains the world; God is triune, existing in three distinct persons: Father, Son, and Holy Spirit, who coexist as one being, the Holy Trinity. God is sovereign, wise, all knowing, transcendent and eternal. God is the origin of love, justice, and mercy. God brings these to us in Jesus Christ, the second person in the Trinity, the Son of God and humanity, fully human, fully Divine.

Sin separates us from God; Jesus Christ comes to us as Mediator and Messiah to atone for our sins so that we can be reconciled to God. We are justified by faith in Christ despite our sin. God chooses us; we are unable to choose God in our depravity, in this way we are elected by God. God loves and desires all to be in relationship with God. No one but the Godhead can judge the eternal fate of humanity.

The Spirit prepares us to receive God's gift of grace through faith and works in our lives by convicting, indwelling, regenerating, interceding, and inspiring us to service. Jesus Christ is the authoritative inspired Word of God, the sufficient revelation of God incarnate, by whom the Holy Spirit bears unique witness through the Holy Scriptures. God was active and inerrant in inspiring the recording and transmission of the Scriptures.

The Church is to go out into the world as God's reconciling community to represent the kingdom of God. We are called to share the love of Christ with all dimensions of life and need. Our representative form of church government is a model for God's reconciling action with humanity; we are the "priesthood of all believers." Our Constitutional history is relevant and weighty yet subordinate to Scripture. Through preaching, teaching, praise, and prayer in worship, and the sacraments of Baptism and the Lord's Supper, we increase our knowledge and love of God and are empowered to service.

The sacraments are visible signs and seals of God's covenant with us. Our Baptism is an outward sign of an invisible grace. Baptism with water represents cleansing and rising with Christ in new life. The church's responsibility in Baptism is to come beside the baptized to teach and support. The Lord's Supper is the sacrament by which we celebrate in remembrance and have our faith nourished by Jesus Christ. Christ instituted this sacrament at his last supper with his disciples by saying that whenever we partake of the Communion meal we do so in remembrance of him; when we share this meal we proclaim the risen Lord's saving death until he comes.

We can always hope because God's love endures and transcends all human limitation. God's will for God's people will be fulfilled under the reign of Christ; All evil will be banished from God's creation. #### Opportunities to Serve in Shenandoah Presbytery

#### Committee on Church Vitality and Transformation (CCVT)

Purpose: To provide processes and support for congregations that have an identified need, willingness, and ability to engage in spiritual and/or programmatic growth which can lead to deeper commitment both within and beyond current membership.

#### Committee on Educational Resources (CER)

Purpose: To provide education and resources in the areas of stewardship, children's ministry, youth and young adult ministry, evangelism, social justice issues, and other areas related to congregational ministry through the use of specialized teams and regional and presbytery-wide training events.

#### Committee on Mission and Outreach (CMO)

Purpose: Coordinate and oversee local, national, and international mission work through congregations and mission communities. CMO will provide information, resources, encouragement and support.

#### Committee on New Congregational Development (CNCD)

Purpose: To formulate and implement a comprehensive plan for location, funding, and development of new congregations and new worshipping communities within the bounds of the presbytery.

#### Committee on Nominations (CN)

Purpose: To nominate to Presbytery individuals to serve on presbytery committees, adhering to established norms of committee membership and representation including vacancies, chairs and vice-chairs; and to nominate persons to serve on presbytery's PJC and as commissioners to Synod and General Assembly meetings.

#### Committee on Pastoral Transition (CPT)

Purpose: To fulfill all Book of Order and Presbytery Manual responsibilities related to oversight of and guidance to churches and pastors in the process of moving from one pastor/congregation relationship to another. These responsibilities include work related to dissolving pastoral relationships, working with churches in all processes leading to the next pastor call, and examining teaching elders for readiness and suitability to receive calls.

#### Committee on Preparation for Ministry (CPM)

Purpose: To oversee the care and examination of inquirers and candidates for ministry, inform sessions of the process for inquiry and candidacy, and conduct examinations of candidates seeking calls within the bounds of this presbytery.

#### Committee on Presbytery Administration (CPA)

Purpose: To oversee the management of presbytery funds, property, and staff.

#### Committee on Relational Ministry (CRM)

Purpose: To fulfill all Book of Order and Presbytery Manual responsibilities related to oversight of and assistance to churches and teaching elders in their ministry. These responsibilities include all matters related to matriculation of new pastors, periodic visits with sessions and pastors, support for clergy wellness and continuing education.

#### Committee on Representation (COR)

Purpose: To advise the Presbytery with respect to membership of its committees and to the employment of its personnel per Book of Order G-3.0103.
