ASSOCIATE GENERAL PRESBYTER

Teaching Elder Nancy Meehan Yao noted that one way the Presbytery fulfills it's calling to be a Community of Christ for Worship, Nurture, and Mission through the generous gifts of the faithful saints and servants that have gone before us. Endowment funds of the Presbytery that are managed by the Corporation include the Lyle Moffett and Bolling Hobson funds for education and training, the Bernice Hiatt and Sam Ramsey funds for foreign mission, the Barnabus Fund for assisting congregations with emergency church building needs and the Presbytery Emergency Fund for pastors.

WORSHIP

Worship was led by Ruling Elder Richard Comstock (Trinity), CRE and Presbytery Moderator Judy Hensley. The sermon was given by Revs Ashley Mejias and Lauren Ramseur, Co-Pastors of Voices of Jubilee, a new worshipping community of the PCUSA, located in Richmond, Virginia. They are a community of incarcerated youth, returning citizens, former prison guards and all those longing for an embodied faith and the liberative word of the Gospel. Through worship, singing, community building and pastoral care they seek to accompany incarcerated youth in their detention. Through advocacy with their legal team and partnering with others to transform the justice system they work towards healing, liberation and the transformation of our community and justice system. Their primary location is at the Bon Air Juvenile Correctional Center in Richmond, where youth from across Virginia who have been sentenced to a term of months or years are incarcerated until they are 21 years old. COMMITTEE ON MISSION AND OUTREACH

Commissioned Ruling Elder Bobby Spurgeon, Chair, reported on the Moffett Fund grants distributed for 2022. (See page 91) The Committee has established a Refugee Resettlement Ministry sub-committee and Ruling Elder Carolyn Thalman briefed the Body on this new ministry.

COMMITTEE ON EDUCATIONAL RESOURCES

Teaching Elder April Cranford, Co-Chair, reported the Big Event held in September was a huge success and a highlight video of the Event was shared by Teaching Elder Tommy Carrico.

AFGHAN REFUGEES REPORT

Teaching Elder Clayton Rascoe, Executive Director of Massanetta Springs Conference Center, reported on their refugee resettlement ministry with Church World Service since early 2017. TE Rascoe updated the Body on the Afghan refugees that are being ministered to at the Center since October. Numerous congregations and individuals from Shenandoah Presbytery have directly contributed to this ministry.

MISSION CONVERSATION

The Body discussed numerous ways congregations are working in mission and future endeavors.

COMMITTEE ON CHURCH VITALITY AND TRANSFORMATION

Teaching Elder David Witt, Chair, noted they continue to provide grants to churches for innovative worship with over \$20,000 distributed to 26 congregations. COMMITTEE ON NEW CHURCH DEVELOPMENT

Teaching Elder Karen Greenawalt, Chair, noted the new worship community, Church of the Wild, meets monthly, and the Community Cup is working to get off the ground. TE Greenawalt reported that although the Stephens City food pantry is thriving, the Faith on Tap is no longer functioning.

COMMITTEE ON PASTORAL TRANSITION

INTRODUCTION OF NEW TEACHING ELDER

Teaching Elder Jonathan Bunker introduced Teaching Elder Caitilin Hoy who has received a call to the Waynesboro Second Church. TE Hoy was asked to give a brief sense of her Christian journey and call to ministry at Waynesboro Second. There were no questions from the floor and the Moderator prayed for the ministry of TE Hoy and Waynesboro Second Church.

COMMITTEE ON RELATIONAL MINISTRY

Teaching Elder Howard Boswell, Chair, gave a brief report as follows. See page 94 for a full written report

Teaching Elder Fletcher Hutcheson, Chair, highlighted the 2021 Acceptance Report as found on pages 99-102. As of October 31, 77% of the 2021 acceptance pledges have been received. The asking letters for the 2022 acceptances

were distributed in October. General Presbyter/Stated Clerk noted the New Monmouth Church was the first to return their acceptance pledge and they will be receiving a small gift in the next week.

The recommendation from the Committee to approve the 2022 Budget was approved as found on pages 95-98.

SHENANDOAH PRESBYTERY CORPORATION

The Body convened at 11:46 a.m. as the Shenandoah Presbytery Corporation by Acting President Alan Garrison.

There being no nominations from the floor, the slate was approved.

Linnea Spradlin, Treasurer, reviewed the following financial information:

The Corporation's fiscal year is from July 1st to June 30th. Net investment income will be available for use/distribution at the end of the current calendar year pursuant to directions on file. Funds will be available only on a quarterly basis and must be requested in writing prior to the end of each quarter. Quarterly payment is necessitated because the Corporation selects long term investments that are not intended to be available on a demand basis. All accounts due to churches and trusts are invested in the same manner as a mutual fund. A valuation of the investment securities held will be made at the end of each quarter to determine the amount allocable to each account held by the Corporation.

Total assets of the Corporation on June 30, 2021 totaled \$17,104,981 up from \$14,214,531 on June 30, 2020. A total of \$483,965 is in non-income-producing real estate, down \$200,000 from the amount reported for 2020 because of the distribution of Camp Paddy Run. For fiscal 2020-2021, interest and dividend income on investments before expenses totaled \$233,641 (1.796% of investments in marketable securities at the beginning of the fiscal year) compared to \$271,086 (2.14%) in the previous fiscal year. Net realized and unrealized gain on marketable securities totaled \$3,406,841 (26.2% of investments in marketable securities at the beginning of the fiscal year) compared to \$404,769 (3.19%) in the previous fiscal year. Investment expenses were \$79,230 compared to \$74,224 last year. The overall investment portfolio (including cash and marketable securities) experienced a total growth of \$3,097,354 or 23% net of gains, deposits, and withdrawals.

Mr. Garrison noted it was not required to be an active member of a Presbyterian Church but noted that has been the precedence.

The Corporation adjourned at 12:00 p.m., and the Body reconvened as the Presbytery of Shenandoah.

SHENANDOAH PRESBYTERY CORPORATION

Investments held by Corporation for this fiscal year ending June 30, 2021 comply with the Corporation's Investment Policy, which is stated as follows: Shenandoah Presbytery directs the Corporation to hold investments that satisfy the divestment criteria prescribed by Mission Responsibility Through Investment ("MRTI"), created and maintained by the Presbyterian Church (U.S.A.). The Corporation supports and follows this policy based on these operational guidelines: The Corporation shall not hold stock directly in debt or equity securities of any MRTI listed entity; The Corporation may hold shares of mutual funds or exchange traded funds which invest in MRTI listed securities subject to the following limitations: The size of the Corporation's indirect listed holdings shall be so small as to be clearly immaterial and without economic influence when considered in relation to the Corporation's investment securities portfolio. This shall be determined by the following de minimis rule: The total value of indirect listed investments shall be immaterial so long as it is less than 2% of the total value of the Corporation's mutual fund portfolio.
