Purpose and Description

Shenandoah Presbytery is "a Community of Christ for worship, nurture, and mission." Worship is the life and breath of a congregation. It is both what we do and who we are, and how we join our whole selves: body, voices, spirit, to the Triune God.

Shenandoah Presbytery wants to join you in a new thing:

"Behold: I am doing a new thing. Do you not perceive it?" Isaiah 43:19.

The Innovations in Worship Grant is not designed to help you keep doing what you have been doing. These monies are to help congregations/worshipping communities reach out in new and creative ways with the love of God, life of Christ, and power of the Holy Spirit.

In order to facilitate congregations' innovations in worship, the Presbytery has made available these funds: Congregations may apply for up to \$1,000 annually, for a maximum of three years. This is a financial needs-based grant. Congregations must show support for this innovation (financially and otherwise) from the Session and congregation.

Report Your Grant Accomplishments

Funds are to be used as requested within the grant year. An initial report of the use of the funds is to be submitted to the Committee on Vitality and Transformation at the address listed above within 3 months of receiving the funds. A second report is to be submitted after 6 months detailing the use of the grant monies and the successes/failures experienced.

A second and/or third year grant request requires a new application detailing the specific needs/desires that justify the application for more monies.

Reports about the effect of the innovation must be made to the CCVT for each grant. Video, photos, feedback from ministry, congregation members and Sessions are all appropriate.

Eligible Activities

- Purchase of materials and/or equipment that will enhance the experience of worship.
- Stipends for soloists and/or presenters who are out of the realm of ordinary worship routines. Salaries and wages will NOT be approved.
- Other be creative!

Eligible Applicants

• Congregations and other worshipping communities within the bounds of Shenandoah Presbytery.

Conditions and Terms of Award

• Grants will be considered and awarded quarterly.
